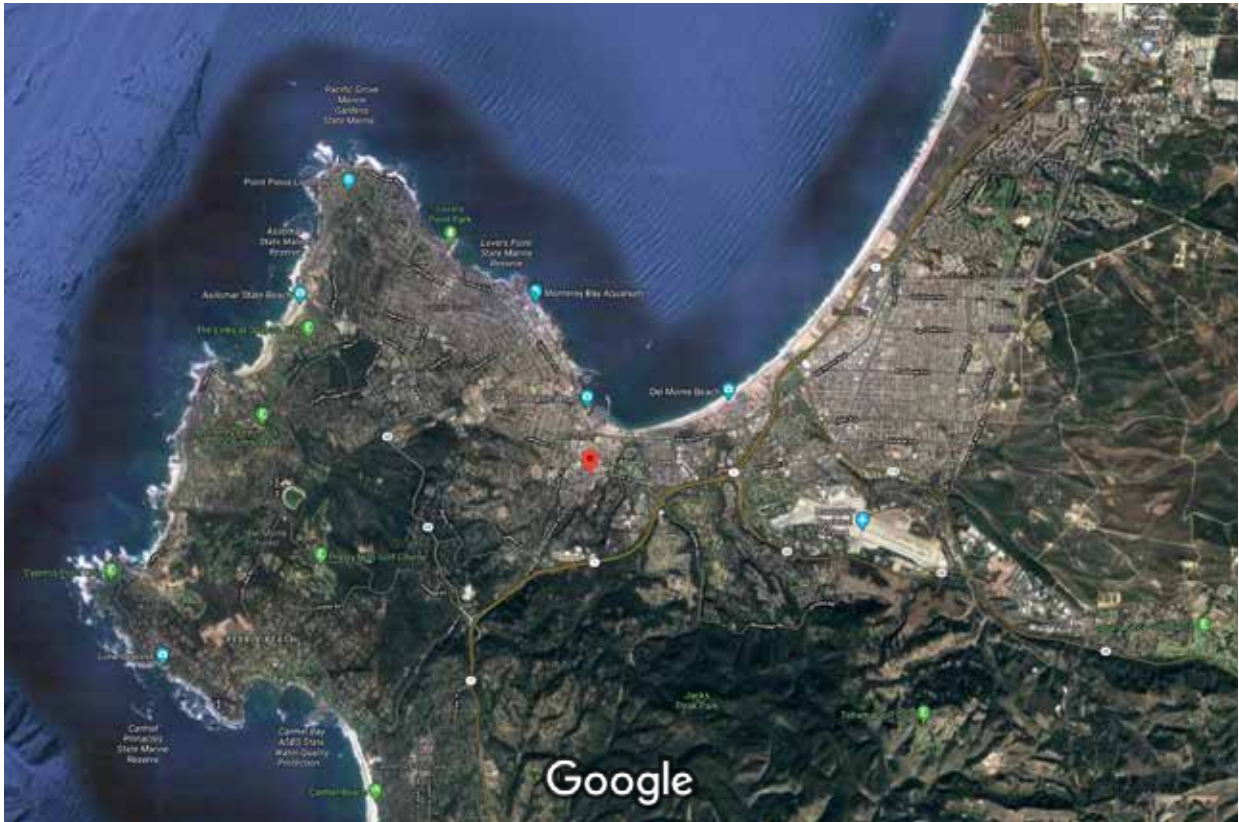
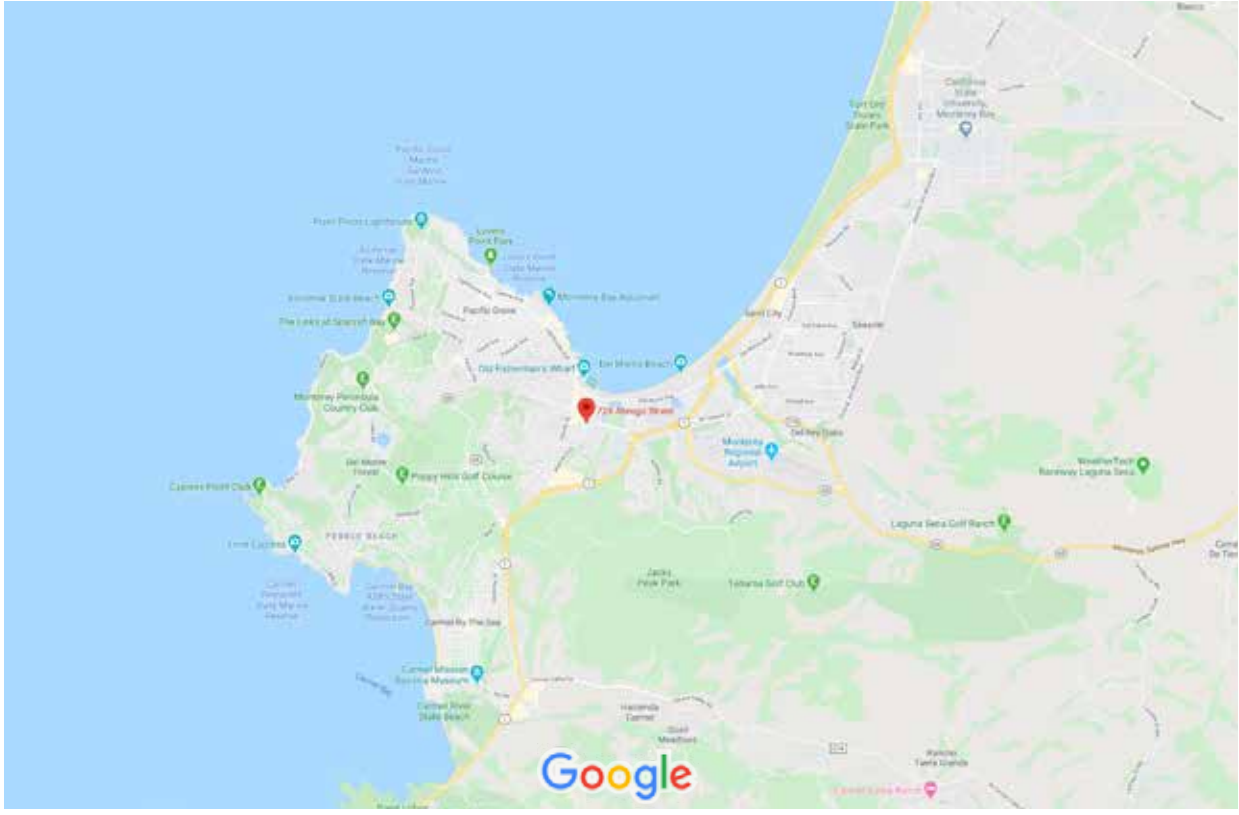

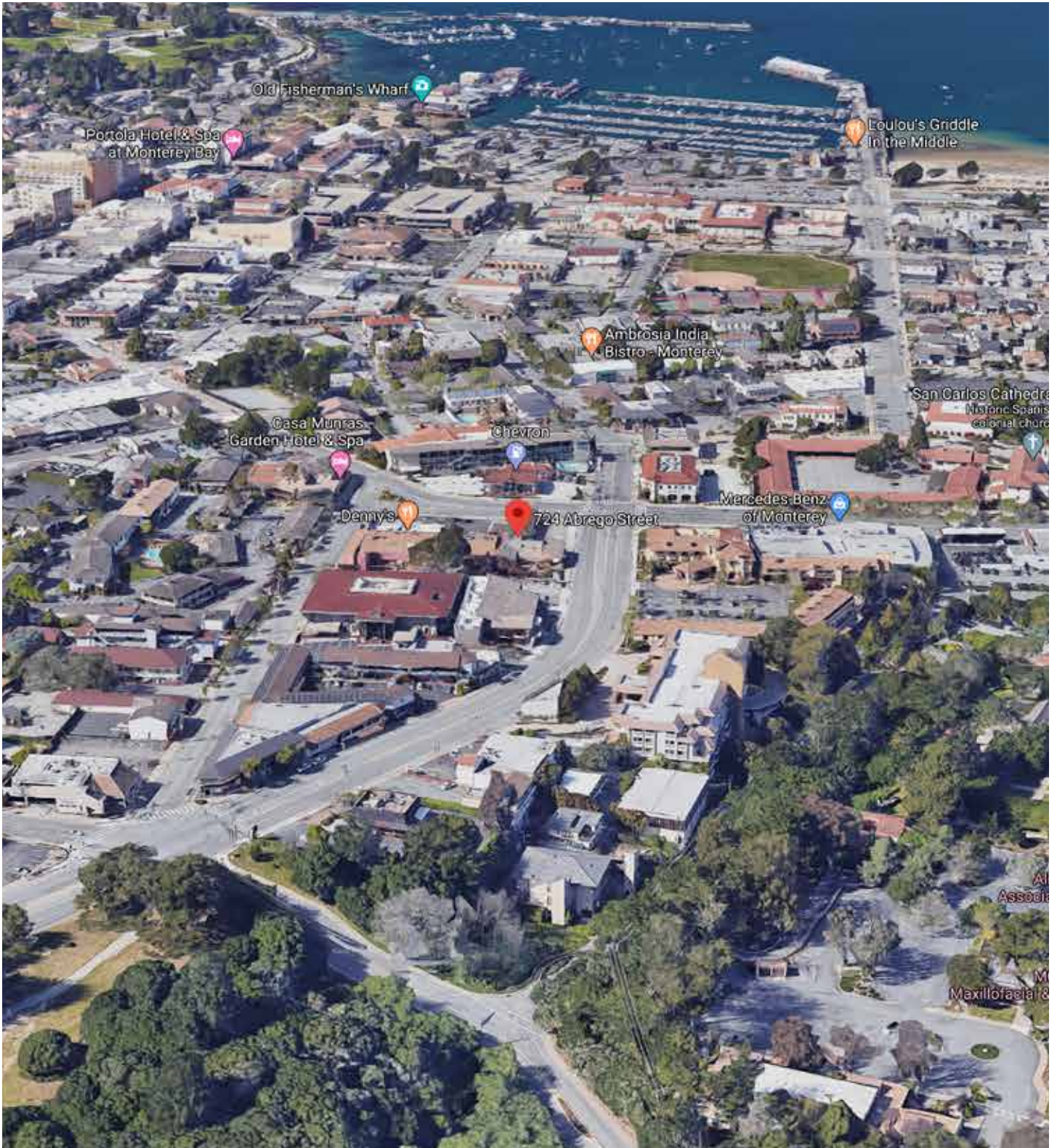
# LOCATION MAP
